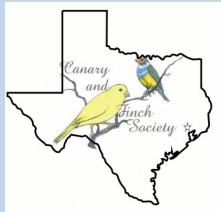

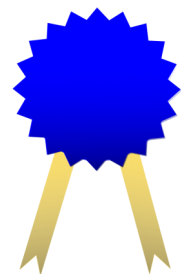

Eggfood Recipe for Babies

Debbie Eaton's Eggfood Recipe

- ◆ 20 cups Protein 25
- ◆ 1/8 cup Nekton MSA minerals
- ◆ 2 lbs thawed frozen green peas
- ◆ 15 eggs boiled
- ◆ 4 cups Couscous
- ◆ 2 cups white sesame seeds
- ◆ (optional) 1- 2 cups Teff seeds
- ◆ (optional) 2 finely grated apples, cored and peeled
- ◆ (optional) finely grated carrots

Use food processor to blend the boiled eggs and frozen peas into the dry Protein 25.

Then pour all into a very large mixing bowl to blend well.

Spoon approximate 4 cups of the blended food into zip-lock bags and freeze. Makes about 12 bags.

For colorfeeding, add about a teaspoon of dry Abba Red or CaroRed to the wet couscous and mix well

to dissolve and then mix with all other ingredients until well mixed with the colorfood.
